FROM THE NORTH /WEST– exit on Avra Valley Rd. and go west to Marana Airport (approx. 5 miles) to Sandario Rd. Turn south on Sandario and go approx. 7 miles to Rudasill Rd. Turn west on Rudasill and go 1 miles to Sanders Rd. and turn south. After you pass the school, take the 2<sup>nd</sup> entrance into the park and go to the far west end of the park to the ball field.  
FROM THE SOUTH/EAST – exit Speedway Blvd. And go west under the freeway. Continue west and it eventually turns into Gates Pass Rd. and goes over the Tucson Mountains and through the County Park to Kinney Rd. Turn right on Kinney and stay on it, past the Desert Museum and then it turns into Mile Wide Rd. Stay on Mile Wide until you get to Sandario Rd. Go north on Sandario to Rudasill and turn west on Rudasill.

**ROLL CALL & INSPECTION: 7:30am for each day** . Inspection committee shall inspect each entry for lameness, fitness to compete and females in season.

A penalty of \$5 will be assessed for each loose dog not competing in the course in progress, and for 5+ minute delays of event.

NOTE: On Saturday - FastCAT events starting w/ #1 beginning at 8:00am, with #2 starting 30 minutes after runs in #1 are completed.

On Sunday - CAT events starting w/ #1 beginning at 8:00am, with #2 starting 30 minutes after runs in #1 are completed.

ALL ANIMALS ON TEST GROUNDS ARE EXPECTED TO BE CURRENT ON VACCINATIONS AS REQUIRED BY STATE LAW.

**Note: Per AKC rules, NO Flexi-leads or Prong collars at the field**

**FastCAT** will be run on a 100 Yard Straightaway, with a 30 yard deceleration area.

**The Timing Devices** for this event will be 2 stopwatches at the finish line which will be averaged for the finishing time.

**Light Blue ribbons will be awarded for qualifying runs.**

**300 Yard Course.** This distance is for dogs 12” or less at the withers and brachycephalic (“flat-faced”) breeds. A dog must complete this course in less than 90 seconds.

**600 Yard Course.** This distance is used for all dogs that do not run the 300 yard course. A dog must complete this course in less than 2 minutes.

**Orange ribbons will be awarded for qualifying runs.**

Coursing Ability Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event (an event is defined by an event number). **To Pass**, the dog must complete the course **with enthusiasm and without interruption** within a stated maximum amount of time. Maximum time: 300 yards - 1½ minutes; or 600 yards – 2 minutes.

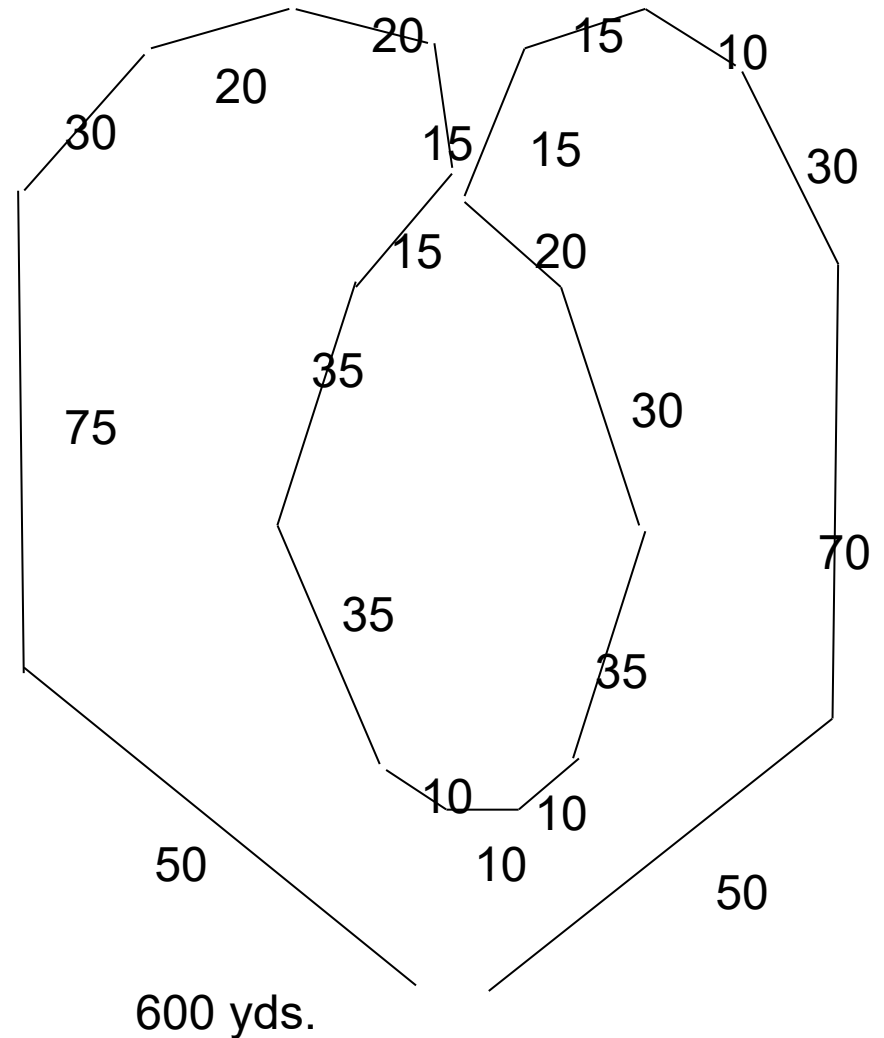
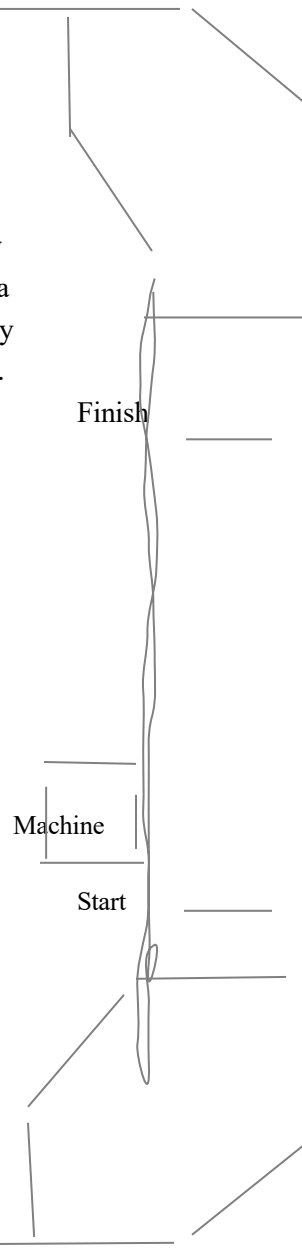
**Dogs will run singularly.** Battery powered, continuous loop lure machines will be used. The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the event. The Field Committee recommends that your dogs be in good physical condition before attempting the course. The Field Committee and the Town of Show Low assume no liability for injury to any person or dog before, during or after these Tests. Please bring your own shade and water. Public restrooms are available across the street from field.

The FastCat's will be run down the south side of the ball field, using the existing chain-link fence as one side and a temporary fencing line will be put up to form the other side of the corridor.

Dogs will be assigned to an hour time slot. Time slots will be assigned by the secretary as entries come in. Exhibitors will receive a communication from the secretary by Friday morning as to the hour their dog(s) will run.

The running order within each hour will be post at the trial. The exhibitors will be expected to remain near the start line to be ready to go to the line when called by the Huntmaster.

Any day-of-trial entries will be put at the end of the lineup.



Course plans for the long CAT's is 600 yds. The first run will be to the left and second run will be to the right.

For the short CAT's the dogs will run ½ the course .
