TEST HOURS: 12:00 PM until completion of all events

ROLL CALL & INSPECTION: 12:00pm. Inspection committee shall inspect each entry for lameness, fitness to compete and females in season. ALL ANIMALS ON TEST GROUNDS ARE EXPECTED TO BE CURRENT ON VACCINATIONS AS REQUIRED BY STATE LAW.

NOTE: Runs are expected to begin approximately 12:30-1:00pm however, due to the field being adjacent to the area where obedience and rally will take place, to respect their need for attention on their tasks, we will only run while participants are not in the rings.

FastCAT will be run on a 100 Yard Straightaway, with a 30 yard deceleration area.

The Timing Devices for this event will be a Laser beam trip timer at the start and finish line.

Light Blue ribbons will be awarded for qualifying runs.

The FastCat's will be run down the far side of the obedience rings area, using the privacy fence put up for the obedience rings as one side and a temporary fencing line will be put up to form the other side of the corridor. NOTE: There will NOT be a completely enclosed corridor so make sure you have a catcher at the end of the run.

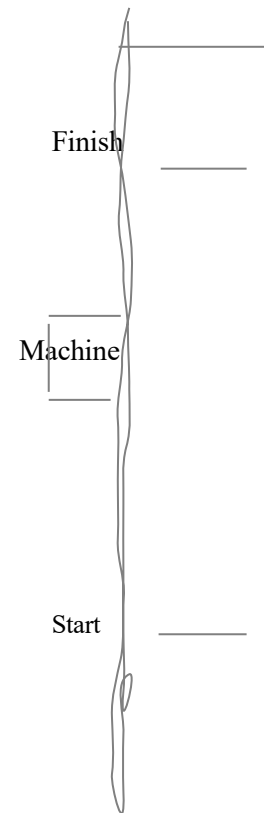
Pre-entered dogs will be assigned to an hour time slot.

Time slots will be assigned by the secretary as entries come in and in accordance with ring times.

Exhibitors will receive a communication from the secretary by Friday as to the hour their dog(s) will run.

The running order within each hour will be post at the trial. The exhibitors will be expected to remain near the start line to be ready to go to the line when called by the Huntmaster.

Any day-of-trial entries will be put at the end of the lineup.
