Direction:

Going from Payson on AZ-260 or east from Globe on AZ60 – into Show Low proceed on Deuce of Clubs Blvd. to White Mountain Blvd., turning right onto AZ-260 East, toward Greer/Eager/Springerville. Go 8.8 miles to Porter Mountain Rd., in Lakeside and turn left onto Porter Mountain. Go 1 mile to the Blue Ridge Elem. School on the left, around the traffic circle.

From the East or northern Arizona (I-40) - go south at Holbrook on AZ-77 and once in Show Low, at the Maverick Gas Station cross AZ-60 and AZ-77 turns into Porter Mountain Rd..

From the main campus entrance, proceed straight ahead, past the parking lot, through the turn-about and then follow the road to the right to the back of the campus and the field will be on your left. RV's will need to park along the edge of the circular turn-about – there are 2, one on each end of the road in the back of the campus. At this moment cars/vans should be able to park along the side of the road closest to the field.

TEST HOURS: 8:00 AM until completion

ROLL CALL & INSPECTION: 7:30am for each day . Inspection committee shall inspect each entry for lameness, fitness to compete and females in season.

A penalty of \$5 will be assessed for each loose dog not competing in the course in progress, and for 5+ minute delays of event.

NOTE: On Friday - FastCAT events will be in 1 hr. blocks, starting at 8:00am w/ #1 block, with #2 starting 30 minutes after runs in #1 are completed.

On Sat & Sun - CAT events will start at approx. 1:00pm, or 30 minutes after the Trial is completed.

ALL ANIMALS ON TEST GROUNDS ARE EXPECTED TO BE CURRENT ON VACCINATIONS AS REQUIRED BY STATE LAW.

Note: Per AKC rules, NO Flexi-leads or Prong collars at the field

FastCAT will be run on a 100 Yard Straightaway, with a 30-40 yard deceleration area.

The Timing Devices for this event will be laser light timer.

Light Blue ribbons will be awarded for qualifying runs.

300 Yard Course. This distance is for dogs 12” or less at the withers and brachycephalic (“flat-faced”) breeds. A dog must complete this course in less than 90 seconds.

600 Yard Course. This distance is used for all dogs that do not run the 300 yard course. A dog must complete this course in less than 2 minutes.

Orange ribbons will be awarded for qualifying runs.

Coursing Ability Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event (an event is defined by an event number). **To Pass**, the dog must complete the course **with enthusiasm and without interruption** within a stated maximum amount of time. Maximum time: 300 yards - 1½ minutes; or 600 yards – 2 minutes.

Dogs will run singularly. Battery powered, continuous loop lure machines will be used. The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the event. The Field Committee recommends that your dogs be in good physical condition before attempting the course. The Field Committee and the Town of Show Low assume no liability for injury to any person or dog before, during or after these Tests. Please bring your own shade and water. Public restrooms are available across the street from field.

The FastCat's will be run down the center of the field, using temporary fence to form a corridor down the center of which the line will run. A 10’x10’ pop-up will cover the starting area and a 40-50 yd. area will be set up as the catch area.

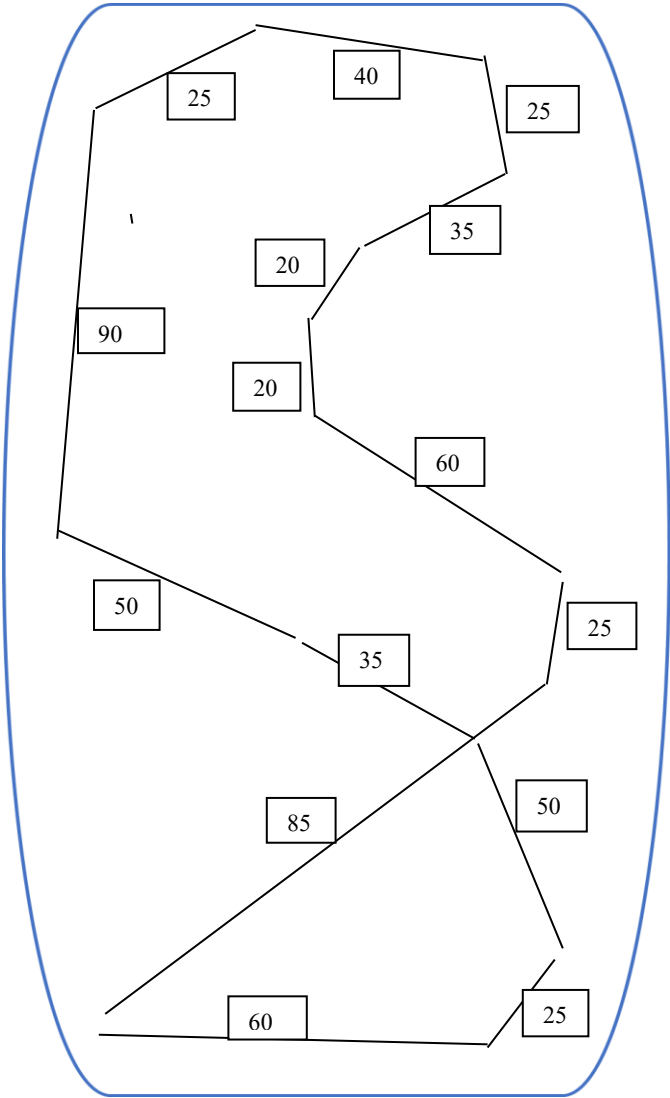
Dogs will be assigned to an hour time slot.

Time slots will be assigned by the secretary communication from the secretary by Thursday morning as to the hour their dog(s) will run.

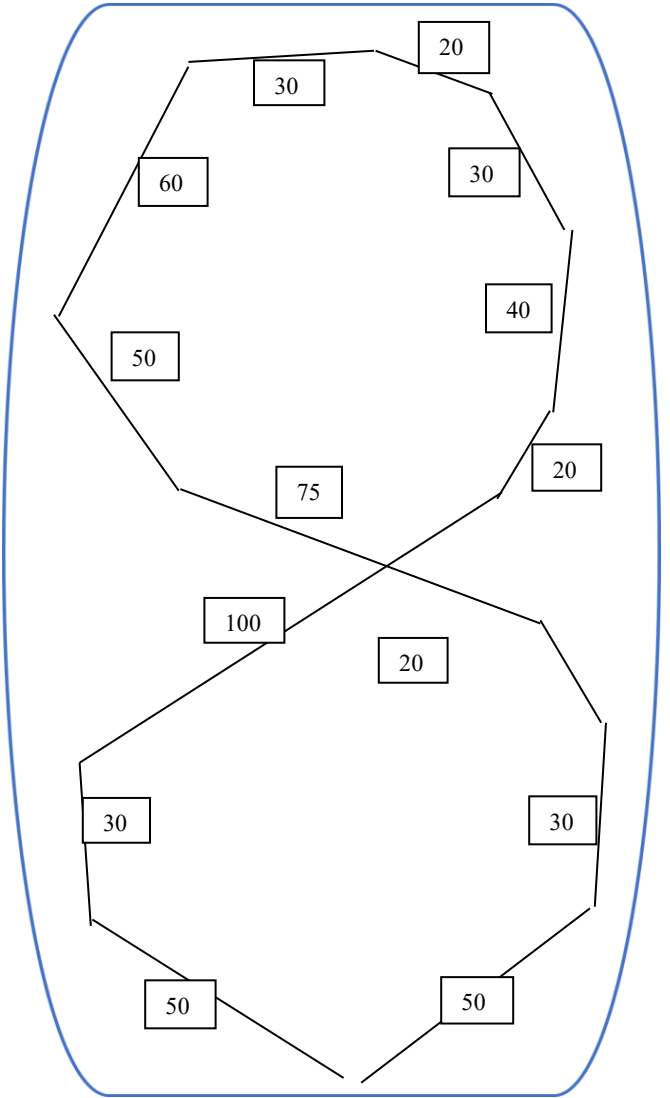
The running order within each hour will be post at the trial. The exhibitors will be expected to remain near the start line to be ready to go to the line when called by the Huntmaster.
