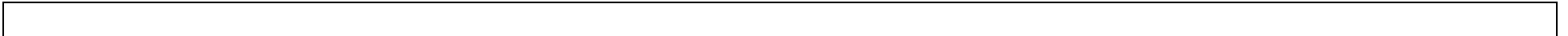

FastCAT's will be limited to 100 entries per event The event will start APPROXIMATELY mid-morning after the Basenji Club people have completed showing and can get the event ready to open.

As the events will be held in conjunction with the conformation show, dogs entered in the conformation event will be allowed to run after they have completed their ring time each day, except for waiting until all groups are completed. The handlers should check in with the trial secretary prior to their conformation time and report an expected time to be able to run. Please note, we can not allow everyone to wait until the end of the day. Dogs that have morning ring times will be expected to run soon after that.

Please be courteous when checking in and do not ask for special consideration due to your busy schedule. 100 runs requires approximately 5 hours therefore we can not schedule everyone to run after groups.

ROLL CALL & INSPECTION: Due to the run-when-available schedule, each dog will be inspected as they arrive to run.

Inspection committee shall inspect each entry for lameness, fitness to compete and females in season.

A penalty of \$5 will be assessed for each loose dog not competing in the course in progress, and for 5+ minute delays of event.

NOTE: Each day - FastCAT events will start approximately 11am -12:00pm, after the persons running the event have completed their ring times and taken care of their dogs.

ALL ANIMALS ON TEST GROUNDS ARE EXPECTED TO BE CURRENT ON VACCINATIONS AS REQUIRED BY STATE LAW.

Note: Per AKC rules, NO Flexi-leads or Prong collars at the field

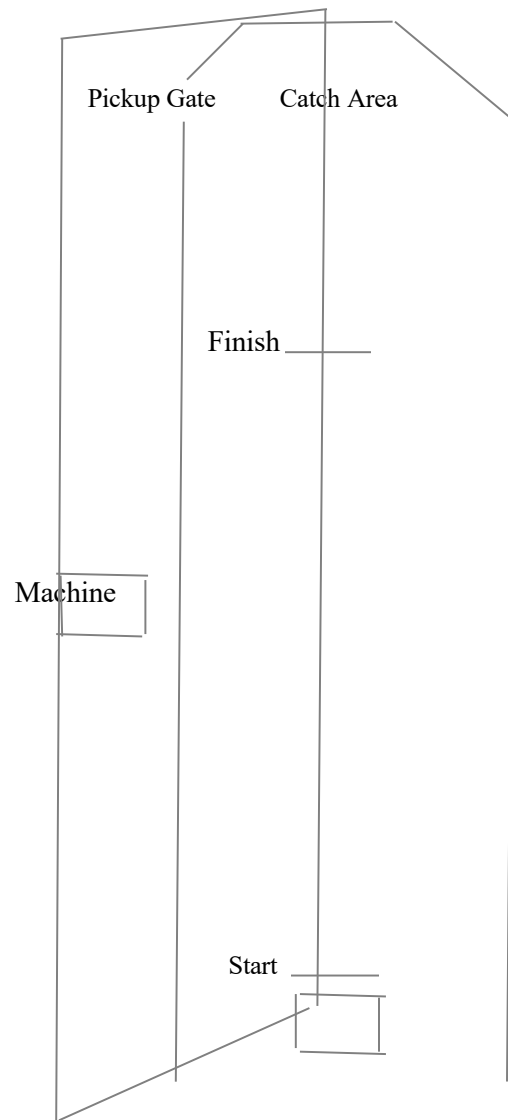
FastCAT will be run on a 100 Yard Straightaway, with a 40-50 yard deceleration area.

The Timing Devices for this event will be lazar light timer.

Light Blue ribbons will be awarded for qualifying runs.

Dogs will run singularly. Battery powered, continuous loop lure machines will be used. The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the event. The Field Committee recommends that your dogs be in good physical condition before attempting the course. The Field Committee the Canyon Cluster and Pima County assume no liability for injury to any person or dog before, during or after these Tests. Please bring your own shade and water. Public restrooms are available across the street from field.

The FastCat's will be run through a corridor of orange plastic temporary fencing set up down the center of the west end of the racetrack infield.
